- WHEN:** SEPTEMBER 6, 2008, A SATURDAY. START TIME IS 9:00 AM. REGISTRATION BEGINS AT 7:30 AM. MATCH STAFF WILL SHOOT ON FRIDAY THE 5<sup>TH</sup>.
- WHERE:** CENTRAL OREGON SHOOTING SPORTS ASSOCIATION (COSSA) RANGE LOCATED AT MILEPOST 24 ON HIGHWAY 20 EAST OF BEND. A MAP IS ON THE COSSA WEBSITE, [www.oregonshooting.com](http://www.oregonshooting.com) HOME PAGE.
- SANCTION:** THIS IS AN IDPA SANCTIONED MATCH.
- STAGES:** THERE WILL BE TEN STAGES WITH AN APPROX. ROUND COUNT OF 160.
- ATTENDEES:** WE WILL LIMIT COMPETITORS TO 100 FOR MATCH DAY.
- LODGING:** WE HAVE MADE ARRANGEMENTS WITH THE SLEEP INN AT A DISCOUNT RATE OF \$79 (1 BED) OR \$89(2 BEDS). THEY ARE HOLDING ROOMS UNTIL 9/1 SO MAKE RESERVATIONS EARLY. USE THE CODE "OREGON STATE IDPA" TO IDENTIFY. THEIR PHONE NUMBER IS 541-330-0050. THE WINDOW FOR RESERVATIONS IS BETWEEN SEPTEMBER 4<sup>TH</sup> AND THE 7<sup>TH</sup>.
- MATCH FEE:** \$55 TO INCLUDE LUNCH. \$25 FOR JUNIORS. WE ARE COUNTING THE LUNCH AS \$5, AND A MATCH FEE OF \$50 AND \$20 RESPECTIVELY. LUNCH PAYMENT IS NOT OPTIONAL. IF YOU HAVE FRIENDS OR FAMILY ATTENDING, AND THEY NEED A LUNCH, ADD THE \$5 FEE PER ADDITIONAL PERSON.
